## NTTA AND MONEYGRAM GIVE CUSTOMERS EASY ZIPCASH PAYMENT OPTION

**PLANO, TX – April 16, 2015** – Paying tolls just became more convenient for North Texas drivers, thanks to a new agreement between the North Texas Tollway Authority and Dallas-based MoneyGram (NASDAQ: MGI), a leading money transfer and payment services company.

NTTA customers can now pay their ZipCash bills at one of the more than 1,100 MoneyGram locations in the Dallas-Fort Worth area or at one of MoneyGram's convenient stand-alone kiosks inside select CVS locations.

Customers can bring their bill and invoice number to any MoneyGram location or kiosk to make cash payments for a \$2 MoneyGram transaction fee.
